The main purpose of any activity in an organization should be to achieve the performance objectives of the organization itself. This means that the goal of internal auditing is to assist the organization to achieve these objectives especially when these activities are concerned with building up organisational execution capabilities, such as learning and development.

Internal audits are about getting information, in a planned way, from a variety of sources and about comparing the gathered data with the requirements of an established quality management system. Internal audits, sometimes called first-party audits, are conducted on behalf of or by an organization itself for the management review and other internal purposes. Normally the internal audits are accomplished by people in the organization who are independent from the activities that are being audited. In many cases, particularly in smaller organizations, independence can be demonstrated by the freedom from responsibility for the activity being audited. The people that are assigned for internal auditing should be competent for such an important task and are credible in the organization.

Today, companies are interested in ensuring return on investment regarding their investment in human capital but often lack an appropriate management system to do so. AQ 10015+ of AdeQuaTE® is the innovative new instrument to help companies to achieve this strategic objective. This workshop will provide the roadmap and key competence for conducting internal audit based on the AQ 10015+ certification standard so that organisations could benefit from the enhanced skill sets of the employees but also the collective impact of learning and development.

This workshop aims at training people who are either assigned to or interested to be internal auditors for their organisation's training management system in compliance with the AQ 10015+ standard.
